## EDUCATIONAL COSTS - UNDERGRADUATE APPLICANT

The current (2019-2020 academic year) overall cost of one academic year for an international undergraduate student is **\$33,998**. Note that visa granting authorities require an F-1 visa applicant to demonstrate sufficient funding for the entire term of their education. Costs for the 2020-2021 academic year will be announced in July 2020.

This outline is provided as a reference. Your actual costs may differ from this information. You should also consider travel and other costs as well when planning for your education.

### PARTIAL TUITION WAIVER ACADEMIC SCHOLARSHIP

Please note that undergraduate international students may qualify for a partial tuition waiver academic scholarship. To qualify for this scholarship for eight (8) semesters or four (4) years of your studies at Cal U, you must verify that you have at least a 2.5 overall grade point average on a 4.0 scale in your secondary and/or previous college studies. The undergraduate admissions official will notify those applicants who qualify for this scholarship.

Note that scholarship recipients must maintain at least a 2.5 overall grade point average on a 4.0 scale throughout their studies at Cal U to retain their scholarship.

When applying, each applicant qualifying for the scholarship must verify support in the amount of at least **\$30,456 (YEAR)**.
